Life Enriching Communities and The Wesley Communities Move Towards Affiliation

Exploring new possibilities in 2021, Life Enriching Communities (LEC) began affiliation negotiations with The Wesley Communities (TWC). LEC and TWC discussed a full affiliation to strengthen their collective impact on senior living services.

"One of our strategic initiatives over the last several years has been to proactively pursue affiliations and partnerships within the senior living sector," says Scott McQuinn, President/CEO of LEC. "The senior living landscape has seen significant consolidation and we believe this will continue. Some of the pressures in the market that are driving this consolidation are the complexities of health care, competition, ability to attract and retain talent, technology, and financial capacity. We are looking forward to working with the team at The Wesley Communities to establish greater efficiencies and effectiveness to benefit the residents and associates of each community."

Three communities are part of the Wesley Community affiliation: Wesley Glen, Wesley Ridge, and Wesley Woods. As of the publishing of this report, the affiliation has been finalized.



First Full Year for Cleveland Affiliation

The 2021 calendar year was the first full year of our affiliation with Concord Reserve in Cleveland. Throughout the year the campus continued to operate with pandemic level restrictions as well as a nationwide staffing shortage that crippled many industries. In fact, our Cleveland market was the most impacted by this shortage. Despite these obstacles, the campus was able to increase occupancy from 115 residents to 175 residents throughout the year. In addition, we improved many systems and processes and began to identify improvements and renovations that need to take place.

Confident Living Serving Residents on the Cincinnati Campuses

Confident Living expanded services to residents living at both the Twin Lakes and Twin Towers communities during the 2021 calendar year. Residents are now able to enjoy the benefits of Care Coordination to enhance the wellness lifestyle they currently enjoy.

When residents enroll, they are supported in navigating the healthcare system outside of our communities. Providing a seamless approach to care delivery and cohesive access to service from other care providers. The Confident Living complement of services has helped residents leverage their on-campus wellness and educational opportunities, as well as support their interest in preventative services.

Twin Lakes Takes on Digital Initiatives

2021 saw the introduction of a variety of digital service delivery initiatives across the Twin Lakes campus. Online ordering became a reality for meals served both in the Copperlight Cafe and the Main Dining Room. The Maintenance Department went digital with 432 non-paper requests logged for the year. In addition, both the Maintenance and Environmental Services departments were able to offer online surveys to better improve service delivery and impact outcomes.




