Greatest Needs

One of our Greatest Needs is long-term nursing care for residents on Medicaid. This reimbursement only covers a fraction of the cost of long-term care. In 2024,**155** residents in Skilled Nursing were supported through Greatest Needs. Your gift to Greatest Needs is also critical in filling gaps and supporting other initiatives within our communities.
